CODE OF CONDUCT FOR STUDENTS

The Students are the real wealth of any institution .Therefore they are required to be goal-oriented, mature and having professional ethics. We require our students to follow the following Code of Conduct:

- During college hours, every student must have his or her Identity Card.
- Students should refrain from engaging in any illegal or anti-social behavior inside or outside of campus
- Students are not permitted to bring outsiders in the college campus.
- Misusing, stealing, defacing, damaging, or destroying the college assets will be severely dealt with.
- Students should go through the notice boards for latest information. They should also check their email accounts daily to learn about any significant directives or orders made by the principal.
- Students should avoid waste drinking water. After using, turn off the taps
- Students are not allowed to use the cell phones or mobile phones within the classes.
- Students must treat all members of the college community with respect, honor, and courteousness.
- Students should not wander in the corridors/ outside the class rooms during the classes.
- Consumption of intoxicants like alcoholic drink or drug, smoking, gutka, tobacco, pan masala and gums are banned in all places over the college and outside the college entrances.
- Organizing meetings and processions in the campus and immediately outside the entrances of the college without the written permission of Principal is strictly prohibited.
- Students are forbidden from speaking to media representatives on behalf

of the college or inviting them to the campus without the principal's prior written consent.

- Assaulting intimidating, bullying, or threatening any member of the college community will be treated as an offence.
- Students are expected to practice environmental and ecological responsibility. Keep the college campus's plants intact.
- During college hours, students are allowed to park their registered vehicles in the "Parking Zone" set aside for them. Two-wheeler riders are required to wear a helmet or other protective headgear.

The Principal may impose severe disciplinary measures against any student who violates the Code of Conduct or fails to adhere to any of its provisions. The principal has the final say on whether to suspend or expel a student for failing to follow any of the notices posted on notice boards or occasionally sent through emails. Students who disregard the college's norms and regulations will face severe punishment /fines.

ADMINISTRATIVE/ SUPPORT STAFF

Administrative/Support Staff would:

CODE OF CONDUCT FOR TEACHERS

Being a member of SSM family, every teacher should follow the guidelines defined by the college. They must also adhere to the rules set out by the UGC for college instructors. A teacher is frequently the subject of criticism both from his students and society at large. As a result, every instructor needs to ensure that his principles and methods are compatible. Care, trust, honesty, and respect are the fundamental ethical principles that reinforce it. The following is a comprehensive code for every teacher:

Teachers' Responsibility Towards Students:

- Be interested and dedicated to the needs of the pupil, as education is the main goal of the teaching profession. This mentality ought to be focused on the individual requirements of every learner. Teachers should be diligent and committed, and if necessary, they should assist the students outside of scheduled class times without any type of fee.
- Even if a student's opinion differs from his own, the teacher must not stop him from expressing it. Instead, the pupil needs to be inspired. A teacher should, among other things, welcome constructive criticism.
- The teacher must try to make efforts to create a learning environment.
 Regardless of caste, creed, religion, gender, or socioeconomic position, all pupil should receive equal treatment.
- The teacher's job is to encourage pupil to become more interested in their studies and to create an inquiry-based mind-set.
- The teacher's job is to instill in the students a scientific and democratic worldview that will help them to become civic-minded, patriotic, and openminded members of society.

Teachers' Responsibility Towards Their Profession

- Certainly, there is no limit to learning. A teacher must constantly stay current in their profession. Additionally, he or she needs to familiarize themselves with current approaches and other applications.
- He/she should involve herself/himself in seminars and workshops where there is interchange of intellectual themes. Therefore, continuing professional development is essential.
- His or her professional responsibilities should include creating innovative teaching methods, curricula, and plans for an improved educational system.

The teacher will be responsible for carrying out the instructional duties of the institution, such as managing college admissions and providing seminars. He or she should also take part in the college's extracurricular activities, such as sports and cultural programmes. This will result in the students' overall development and a friendly relationship with the teacher.

CODE OF CONDUCT FOR PRINCIPAL

Principal should:

- Adhere to a responsible pattern of conduct demanded or expected of him by the community.
- Manage his private affairs in a manner consistent with the dignity of the profession.
- Discourage and not indulge in plagiarism and other non-ethical behavior in teaching and research.
- Participate in extension, co-curricular and extra-curricular activities, including the community service.
- Refrain from allowing considerations of caste, creed, religion, race, gender, or sex in their professional Endeavour.
